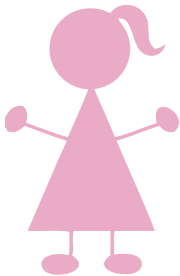

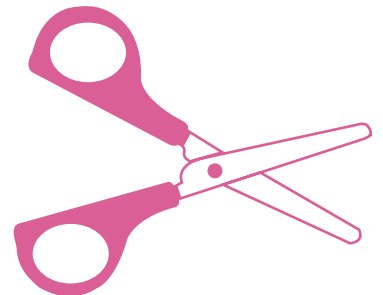
Our mission is to provide stable Christian homes for girls from crisis backgrounds with the commitment to developing mature, Godly women.
